- If you die, your estate will be relieved of any further obligation for payment under the Contract, not then due and owing.

- Cancellation must be submitted 15 days prior to the next billing date (1st of the month)
- Buyer will be charged \$50 for an early termination of annual contracts made prior to 9/1/2017.
- Cancellations on annual contracts made on 9/1/2017 or after cannot be cancelled during the first 12 month period of membership.

Notice of cancellation must be in writing, signed by the Buyer and mailed, by registered or certified U.S. Mail, to the Seller, at the address indicated herein. Such notice shall be accompanied by contract forms, membership cards and any other documents or evidence of membership previously delivered to the Buyer. All moneys paid pursuant to this Contract and any credit or loan agreement for such payment, cancelled for any of the above reasons only, will be refunded and returned by the Seller within 15 business days of receipt of such cancellation notice, PROVIDED HOWEVER that for all moneys paid pursuant to this Contract, cancelled for any of the reasons listed in PARAGRAPH "2", Pinnacle Athletics may retain money for expenses incurred and the portion of the total price representing services used or completed, can demand the reasonable cost of good and services which the Buyer has consumed or wishes to retain after Contract cancellation; and may require written substantiation of such grounds for cancellation. The effective date of cancellation and calculation for any money subject to refund under this paragraph is the date of receipt by Pinnacle Athletics of such notice and is not retroactive to any prior date. The member will be deemed to have used, completed or consumed services or goods under this Contract for which Pinnacle Athletics may retain money until notice of cancellation under this paragraph is received by Pinnacle. Cancellation via fax, email, phone, standard mail and any verbal agreements between staff and Buyer will not be accepted under any circumstances whatsoever. Buyer is responsible to retain his/her copy of the Pinnacle Athletics cancellation form as proof of cancellation. Buyer agree to pay any overdue balance before they are able to cancel their contract. Buyer also agrees to pay cancellation fee, if applicable.
